

TO THE TV-RADIO REPRESENTATIVES

The accreditation procedure to the 2016 CIK-FIA European and World Championships has started.

Please note that this procedure is available only for TV-Radio representatives (journalists and operators).

Journalists and Photographers representing the other media have to request their accreditation to the CIK-FIA.

The accreditation request must arrive by April 8th 2016.

To request the accreditation to the single event, the deadlines are:

WSK Promotion's Press Office wants to assure its whole availability in order to facilitate the work of those are engaged in the popularization of karting and that will give prominence to the 2016 WSK events.

To make this possible, TV-Radio accreditation is granted exclusively to those people who have a professional activity in this field. We are sure that in this way the job of operators of information will be facilitated.

For this reason we kindly would ask all TV-Radio representatives their collaboration, thanking them in advance for the attention they will devote us.

INTRODUCTION

1. Access to the Circuit

The accredited TV-Radio representatives can enter into the Circuit facilities, the Press Room and the Paddock area. The press accreditation gives no admission to the track and the Parc Fermé. The permanent pass "Media-Press", issued by **CIK-FIA** as well as the **local ASN**, allows free access to the circuit facilities but not to the track or the Parc Fermé.

2. Applicants

TV-Radio networks that intend to realize journalistic reports about CIK-FIA events, can require the press accreditation. Commercial organisations, commercial free-lance operators, besides not journalistic personnel from networks, cannot be accredited (read further details at point 3). Networks can require the accreditation for a maximum of three appointees for each TV-Radio network.

3. Norms and restrictions

Radio-TV journalists or operators that intend to follow this event only for commercial purposes, as selling video footages to drivers, team members or private people, are excluded from accreditation. Television shootings have only to be realized by accredited cameramen and only after formal authorization by WSK Promotion and the media rights holder of the events.

WSK Promotion besides reserves the right to require copyright free copies in limited number to be fixed on spot, of the material realised during the WSK events. TV shootings that will be provided can be used, mentioning the author, for WSK Promotion media activities.

4. Press accreditation procedure

Applications for accreditation must reach, within the established terms, WSK Promotion's Press Office. All the applications will be checked in all their data. Those ones containing untruthful information will be rejected. Released passes will however lose their value and they will be immediately retired (even during the event) if, even in a second time, information in the applications should be false.

To require the admission to the track area, TV Operators must enclose in their application for accreditation a copy of the Accident Insurance Policy that explicitly covers the risks deriving from the accomplishment of their professional activity in motor-racing.

Applications that will not reach within the established terms or uncompleted in their enclosed documentation will be rejected. **Besides, WSK Promotion by consent with the circuits' holders, reserves the right to impose a maximum number of accreditations to TV Operators and to fix a maximum number of accesses to the track, in order to follow the best safety conditions.**

5. Regulation to enter the track

The Press Office, by mutual consent with the Clerk of the Course and the chiefs of the tracks, will establish the track zones, whose admittance and stay won't be allowed during the race (Red Zones). The entry to the track will be allowed only to those TV Operators who are provided with the WSK pass **PISTA/TRACK** and with the official breast-jacket dispensed by the Press Office staff.

PROCEDURE

1. How to send the application for accreditation

Applications for accreditation must be filled on the **TV-Radio Representatives Form** outfitted by WSK Promotion for Networks or freelancers and they must include the following enclosures:

- a digital photo of the Journalists;
- **(for TV Operators only) a copy of the Accident Insurance Policy that explicitly covers the risks deriving from the accomplishment of their professional activity in motor-racing. The document must be drawn up in one of the following languages: Italian, English, French. Other languages will be not considered.**
- a copy of the official National Press Card;
- a copy of the permanent 2016 Media Pass, issued from CIK-FIA or from the National Sporting Authority of the Country of origin, if in possession of it.

Applications will have to reach within April 8th, 2016 to the address press@wskarting.com

2. Result communication

The result to the application for accreditation will be communicated to the addresses written in the respective forms, together with (in the case the application is accepted) the instructions to collect the pass on the spot.
